Causes irritation to the gastrointestinal tract. Symptoms may include nausea, vomiting and diarrhea. May have moderate toxic effects if consumed in large enough quantities. Ingestion of large amounts may be corrosive to mouth, throat and GI tract and produce abdominal pains, vomiting, diarrhea, and circulatory collapse.

Skin Contact:

Contact with dry material causes irritation. In aqueous solution it is a strong caustic and as such may have corrosive effects on the skin.

Eye Contact:

Causes extreme irritation, redness, pain and possibly corneal damage.

Chronic Exposure:

A chronic dermatitis may follow repeated contact with this substance.

4. First Aid Measures

Inhalation:

Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.

Ingestion:

If swallowed, DO NOT INDUCE VOMITING. Give large quantities of water. Never give anything by mouth to an unconscious person. Get medical attention immediately.

Skin Contact:

Immediately flush skin with plenty of water for at least 15 minutes. Remove contaminated clothing and shoes. Get medical attention. Wash clothing before reuse. Thoroughly clean shoes before reuse.

Eye Contact:

Immediately flush eyes with plenty of water for at least 15 minutes, lifting lower and upper eyelids occasionally. Get medical attention immediately.

5. Fire Fighting Measures

Fire:

Not considered to be a fire hazard.

Explosion:

Not considered to be an explosion hazard. An explosion occurred after mixing sodium hydrosulfite, aluminum powder, potassium carbonate and benzaldehyde.

Fire Extinguishing Media:

Use any means suitable for extinguishing surrounding fire.

Special Information:

In the event of a fire, wear full protective clothing and NIOSH-approved selfcontained breathing apparatus with full facepiece operated in the pressure demand or other positive pressure mode.

6. Accidental Release Measures

Ventilate area of leak or spill. Wear appropriate personal protective equipment as specified in Section 8. Spills: Pick up and place in a suitable container for



reclamation or disposal, using a method that does not generate dust.

7. Handling and Storage

Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Isolate from incompatible substances. Containers of this material may be hazardous when empty since they retain product residues (dust, solids); observe all warnings and precautions listed for the product.

8. Exposure Controls/Personal Protection

Airborne Exposure Limits:

Ventilation System:

A system of local and/or general exhaust is recommended to keep employee exposures as low as possible. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at its source, preventing dispersion of it into the general work area. Personal Respirators (NIOSH Approved):
